

CFCU 75th Anniversary Rules: Cisco's Landscaping

OFFICIAL RULES

SPONSOR

The Promotion is offered and sponsored by Christian Financial Credit Union ("Sponsor"), 35100 Van Dyke Ave, Sterling Heights MI 48312.

ELIGIBILITY

Promotion is open to individuals who are members of Christian Financial Credit Union who submit a giveaway entry form during the Promotion Period. You must be at least eighteen (18) years of age at the time of entry, or the legal age of majority in your jurisdiction, whichever is greater. Employees or Directors of Christian Financial Credit Union and members of their immediate families (including biological, step or in-law) including parent, grandparent, child, sibling or spouse of any of the foregoing (regardless of where they live) and those living in the same households as any of the above, whether related or not, are ineligible. Promotion is subject to all applicable federal, state, and local laws.

PROMOTION PERIOD

The Promotion begins on August 4, 2025, at 12:00 AM Eastern Standard Time (EST) and ends on September 5, 2025, at 11:59 PM EST ("Closing Date"). The Sponsor's server is the official time-keeping device for the Promotion.

ENTRY

Each eligible individual may enter the CFCU 75th Anniversary Giveaway: Cisco's Landscaping promotion in the following way. One entry is allowed per individual after they become eligible. All members who have submitted a giveaway entry form during the promotion period will be eligible to win a prize. Those who have already won a prize in the CFCU 75th Anniversary giveaway during the promotion period are no longer eligible for future drawings from this promotion. Drawings will begin September 8, 2025, from all entries submitted between August 4, 2025, at 12:00 AM Eastern Standard Time (EST) to September 5, 2025, at 11:59 PM EST.

PRIZE

SELECTION OF WINNER

On Sept. 8, 2025, the Sponsor will conduct a random drawing to select the potential winner and any alternate winners from all valid entries received within the Promotion period. Odds of winning depend on the total number of eligible Entries received throughout the Promotion. The decisions of the Sponsor shall be final and binding.

On Sept. 8, 2025, the Sponsor will contact the winner using the phone number and email address on the individual's account. It is the responsibility of the member or individual to notify the Sponsor of any changes to the phone number and email address on file. If the winner fails to respond over phone or email after five (5) business days from original contact, an alternate winner will be contacted. The alternate winner will be contacted in the same manner and given the same time frame to respond.
